**Memorandum of Understanding (MoU) for Establishing & Running of RASSA  
EKAL VIDYALAYA at Naugarh, Chandauli, UP**


This MoU is entered into between Royal Association for Science-led Socio-cultural Advancement (RASSA), New Delhi and Rural India Development Foundation (RIDF), Varanasi on 01.09.2018 for establishing and running of RASSA EKAL VIDYALAYA in in tribal belt of Naugarh tehsil, Chandauli district of Uttar Pradesh.


1. RIDF, Varanasi shall establish and run the RASSA EKAL VIDYALAYA for which financial support shall be provided by RASSA, New Delhi till March 2021.
2. One time support of Rs. 5000/ required for establishing the RASSA EKAL VIDYALAYA and running expenditure of Rs. 3000/ per month shall be borne by RASSA.
3. Support for this year shall be proportionate to annual proposed running expenditure + one time establishment cost as per RIDF proposal vide their email dated 04.08.2018. Payment in equal quarterly instalment shall be released.
4. Next instalment of support shall be released on furnishing the previous account.
5. Sri J N Singh, LM 089 and Dr Manvendra Bahadur Singh, FM 052 as RASSA representatives shall monitor the progress of RASSA EKAL VIDYALAYA.
6. Father/ Guardian of student shall enrol him/her self as RASSA Kisan Member at a prescribed fee of Rs. 100.
7. MoU can be extended for period beyond March 2021 depending on its success. It can be cancelled in between based on report of RASSA representatives for non-performance.
8. RIDF, Varanasi shall not use the name of RASSA for any purpose other than RASSA EKAL VIDYALAYA.
9. No eatable should be provided to students of RASSA EKAL VIDYALAYA.
10. RIDF, Varanasi shall periodically share photographs of activity of RASSA EKAL VIDYALAYA to RASSA at [royal.association2016@gmail.com](mailto:royal.association2016@gmail.com)




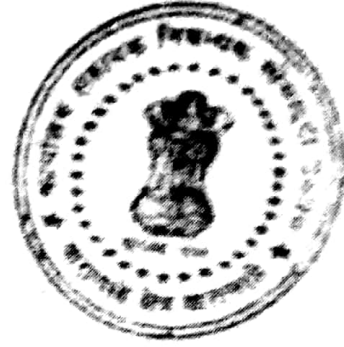
