- 2. RASSA MAHARSHI SAMMAN: This award shall be given towards Outstanding Contribution of such luminary members who have vastly contributed in their fields and also for welfare of people in various capacities. The number of such award may be three (3). The award shall carry a citation and medal.
- 3. RASSA YASHSVI SAMMAN: This award shall be given towards Distinguish Service by such luminary members who have enormously contributed in strengthening the Society and their fields of specialization too. The number of such award may be nine (9). The award shall carry a citation and memento.

Guidelines:

- 1. Award shall only be given to the members (founder/life). Life members enrolled up to 30th June 2022 are eligible for participation in the RASSA awards 2022.
- 2. Only online nominations shall be accepted from members for any of above-mentioned awards up to 15th September, 2022 (Midnight) at royal.association2016@gmail.com.
- 3. Member shall nominate only one member for any one of above-mentioned awards except RAJARSHI SAMMAN. More than one nomination by a member for above-mentioned award shall be rejected.
- 5. Recipients of last year RASSA awards cannot be nominated by any member.
